Beneficiaries do not have to pay for service enrolment. To be eligible applicants must be recipients of the Social Welfare Department's Comprehensive Social Security Assistance Scheme at the time of assessment; aged 65 and above; not residing in residential care homes for the elderly; and not owning a smartphone. All applicants must be referred by social workers of the <u>District Elderly Community Centres (DECCs) or Neighbourhood Elderly Centres (NECs) operated by the 12 NGO partners</u>. Social workers will conduct an initial assessment of elderly
